Standing Instructions regarding Leave and Fee applicable to Chairman, Sub: Permanent Lok Adalat.

Sir,

As directed, following instructions are issued towards leave and fee admissible to Chairman, Permanent Lok Adalat.

- All the Chairmen, Permanent Lok Adalat shall be entitled to avail 16 days Casual leave per year. The record of the same may be maintained at your end. No other leave shall be admissible to them.
- As per Rule 3(2) of the Permanent Lok Adalat (Other Terms and 2. Conditions of Appointment of Chairman and Other Persons) Rules, 2003, a Chairman, Permanent Lok Adalat shall be entitled to a monthly fee (not salary) of last drawn salary less the amount of pension received by him and their fee may be calculated accordingly.
